# 2024 Information

**Please read carefully. There are some changes.**

- Wylie Swim Club stresses and strives to maintain a family oriented atmosphere with Christian values emphasized.
- The pool opens at noon on Memorial Day, Monday, May 27<sup>th</sup> and closes at 8:00pm on Labor Day, Monday, September 2<sup>nd</sup>.
- **Please Note:** On school days in August, pool hours will be 4:00-8:00pm.
- The pool's membership is private and limited to 185 family memberships.
- A family membership consists of: head of household, spouse (if applicable)& all unmarried children **living in the home under the age of 25**. A caregiver may be added for an additional charge of **\$50** if this person will be bringing minor children to the pool while parents are working. **This person must sign the Rules and the Waiver sheet.**
- 1<sup>st</sup> year's membership fee for new members is \$500.00.
  - Active Military families receive a 10% new membership discount (\$450.00).
- Renewal fee for each following year's membership is offered at \$420.00.
  - Active Military families receive a 10% renewal discount (\$378.00)
- **Each family member over age 12 must sign the Wylie Swim Club's Rules & Regulations.**
- Membership entitles the member families free access to the pool as often as desired during regular pool hours.

- Only 4 guests are allowed per member family at any one time, and must be accompanied by a member - cost per guest is \$9.00 each at the gate - or - guest pass booklet of 10 passes for \$80.00 may be purchased.
- No Lifeguard. Signed waiver required to swim.
- Private Parties are available for members and their guests outside of pool hours -  
2 hrs. - 40 people or less - \$200.00  
2 hrs. - parties with 41 to 80 people - \$275.00. Parties of more than 80 people please check with management for pricing and regulations. **The member is responsible for the welfare and conduct of their guests.**

# Pool Guidelines for all Swimmers

- Weight limit on the diving board and slide is 250 pounds.
- We do not allow “water wings” on the slide or diving board. This is because they have a tendency to slip and increase risk to a new swimmer. Wings with an attached flotation vest are allowed.
- Please go down the slide face up and feet first. Sliding otherwise is likely to result in a face injury.
- No objects are allowed onto the slide or diving board.
- Please walk around the board, instead of simply going over it. This way you do not disrupt a jump and cannot trip over the board.
- Please jump straight off the board. Jumping to the side increases the risk of hitting your head against the cement semi-circle around the board.
- One bounce on the diving board per jump, please. More bounces increases the risk of slipping and falling.
- Please do not linger on the board or slide for more than five seconds.
- Please do not jump from the board or slide onto an inflatable, you might slip and hurt yourself.
- Please do not hang onto the slide or diving board; you might be injured by someone using them.
- Please do not swim in the diving circle or immediately in front of the slide. Someone might land on you.
- Please do not play or stand on the water rope.
- Please allow Sunscreen product to dry at least 15 minutes before entering the water. This helps keep your swim club water clean!
- Please DO NOT enter the pump room or concession stand, these areas are for current employees only.
- Please leave your trash in a trash can, instead of the ground. Leaving food out will attract bees, ants, and other unpleasant creatures.
- Please do not sit on our tables. It leaves dirt on the seats from your shoes.
- No alcohol, tobacco products, vaping, abusive language, obscene gestures or clothing or accessories displaying any of these items will be allowed.
- The Volleyball court is not a sand box. No playing with toys or shovels is allowed.
- Be sure to use the foot washing station when finished on the volleyball court.

## **RULES AND REGULATIONS**

### **WYLIE SWIM CLUB HAS NO LIFE GUARDS ON DUTY-SWIM AT YOUR OWN RISK**

These rules and regulations are designed to enhance clean moral behavior while emphasizing the importance of family activities.

1. No alcohol, tobacco products, vaping, abusive language, obscene gestures or clothing or accessories displaying any of these items will be allowed. No public displays of affection, excessive rough play, running, skateboarding, skating, or riding in or around the pool area or extremely loud music will be allowed. **No disrespect towards any Swim Club staff will be tolerated.**
2. All swimwear must be **modest** and in good taste. Women and girls may be asked to wear a t-shirt over their swimsuit if it is too revealing. All decisions regarding swimwear will be left to the discretion of the managers and staff.
3. The managers and/or employees of the Club will enforce all rules and regulations of the Wylie Swim Club.
4. Members are allowed to bring their own food & non-alcoholic beverage as long as it is not in glass containers. Each member is required to clean up after themselves and to properly dispose of their trash.
5. The Wylie Swim Club will not be responsible for lost or stolen personal items including jewelry, clothing, shoes, etc.
6. The Wylie Swim Club's membership is private and limited to family memberships. A family membership consists of the head of household, spouse (if applicable), and all unmarried children living in the home under the age of 25. All family members must live in the same house. **A grandparent or caregiver may be added to your membership for an additional \$50 fee.**
7. **Children under the age of 12 must be accompanied by a parent or guardian.** Children 12 or over without parental direction may be asked to demonstrate swimming abilities for safety purposes before being allowed to swim.
8. Members and guests must adhere to all posted rules on the premises. Showering before entrance to the pool is a City Ordinance and must be abided by.
9. Guests must be accompanied by a member. Only 4 guests per member family are allowed at any one time. Guests must check-in and pay a gate fee even if they are not swimming. Guest pass booklets may be purchased at the counter. All guests must leave the premises at the time the member leaves.
10. It is understood that the member is responsible for the welfare and conduct of their guest(s). The guest(s) must adhere to all rules and regulations of the Wylie Swim Club.
11. Use of floats, tubes, water guns and other water toys in the pool will be left up to the discretion of the Wylie Swim Club staff. **Weight limit on the diving board and slide is 250 pounds.**
12. **Small toys** that can float into the filters are not allowed.

13. Members will be required to check-in at the counter before entering the pool facility. A master list of all members will be kept at the pool. Upon arrival, members will be asked to give their name and possibly some form of identification. Children checking in will be required to give their name and birthdate. Any misuse or abuse of this system will be cause for removal from the pool and possible revocation of membership privileges.

14. Wylie Swim Club assumes no responsibility for the ingredients of the concessions. It is your responsibility to determine if there is any allergy to any of the products..

15. Private parties are available on a first come, first serve basis. Parties can be held at times approved by the Club managers. The cost of the party shall be determined at the discretion of the Club managers payable in advance and shall be held for all or part of a two hour period set at the discretion of the Club managers. No lifeguard will be provided for private parties. All Club rules will be in effect during private parties.
