2025 Information

Please read carefully. There are some changes.

- Wylie Swim Club stresses and strives to maintain a family-oriented atmosphere with Christian values emphasized.
- The pool opens at noon on Memorial Day, Monday, May 26th and closes at 8:00pm on Labor Day, Monday, September 1st.
- The pool's membership is private and limited to 185 family memberships.
- A family membership consists of: head of household, spouse (if applicable) & all unmarried children **living in the home under the age of 25**. A caregiver may be added for an additional charge of **\$50** if this person will be bringing minor children to the pool. **This person must sign the Rules and the Waiver sheet. They must also be a legal adult and not the same age as, or younger than, any listed children.**
- 1st year's membership fee for new members is **\$500.00**.
 - Military, firefighters, law enforcement and EMS/EMT families receive a 10% new membership discount (\$450.00).
- Renewal fee for each following year's membership is offered at **\$420.00**.
 - Military, firefighters, law enforcement and EMS/EMT families receive a 10% renewal discount (\$378.00)
- **Each family member over age 14 must sign the Wylie Swim Club's Rules & Regulations.**
- Membership entitles the member families free access to the pool as often as desired during regular pool hours.

Pool Rules & Regulations

WSC Copy

Note: Wylie Swim Club has no lifeguards on duty, swim at your own risk.

General Conduct

- No alcohol, tobacco products, vaping, abusive language, or obscene gestures.
- No public displays of affection, excessive rough play, running, skateboarding, skating, or extremely loud music.
- Disrespect towards Swim Club staff is not tolerated.

Swimwear

- Swimwear must be modest and in good taste.
- Women and girls may be asked to wear a t-shirt over revealing swimsuits, at the discretion of managers and staff.

Membership

- Membership is private and limited to family memberships.
- A family membership consists of the head of household, spouse (if applicable), and all unmarried children living in the home under the age of 25.
- Grandparents or caregivers may be added for an additional \$50 fee. Please note, the listed caregiver must be a legal adult, AND not the same age as or younger than any listed children.

Children

- Children under **14** must be accompanied by a parent or guardian.
- Children **14** or over may be asked to demonstrate swimming abilities for safety purposes before being allowed to swim.

Guests

- Guests must be accompanied by a member.
- Guests must check-in and pay a gate fee even if they are not swimming.
- Guest pass booklets may be purchased at the counter.
- Guests must leave when the member leaves.
- Members are responsible for the welfare and conduct of their guests.

Pool Use

- Showering before entering the pool is required.
- Please allow sunscreen product to dry at least 15 minutes before entering the water. This helps keep your swim club water clean!
- Please do not play or stand on the water rope.
- Floats, tubes, and water toys are allowed at the discretion of the staff.
- Small toys that can float into the filters are not allowed.

Slide / Diving Board

- Weight limit on the diving board and slide is 250 pounds.
- We do not allow “water wings” or life vests on the slide or diving board. This is because they tend to slip and increase risk to a new swimmer. Both the slide and diving board are meant for swimmers.
- Please go down the slide face up and feet first. Sliding otherwise is likely to result in a face injury.
- One person at a time on the diving board, slide, AND the slide ladder (it’s a long way down).
- No objects are allowed onto the slide or diving board.
- Please walk around the board, instead of simply going over it. This way you do not disrupt a jump and cannot trip over the board.
- Please jump straight off the board. Jumping to the side increases the risk of hitting your head against the cement semi-circle around the board.
- One bounce on the diving board per jump, please. More bounces increase the risk of slipping/falling.
- Please do not linger on the board or slide for more than five seconds.
- Please do not jump from the board or slide onto an inflatable, you might slip and hurt yourself.
- Please do not hang onto the slide or diving board; you might be injured by someone using them.
- Please do not swim in the diving circle / immediately in front of the slide. Someone might land on you.
- Please no “cartwheeling” off the diving board for safety reasons.

Facilities

- No entering the pump room or concession stand; these areas are for management & employees only.
- Clean up after yourself and dispose of trash properly.
- Do not sit on tables to avoid dirtying the seats.

Volleyball Court

- No playing with toys or shovels; the volleyball court is not a sandbox.
- Use the foot washing station after playing on the volleyball court, and before re-entering the pool.

Member Sign-In

- Members must sign in at the counter before entering the pool facility.
- A master list of all members will be kept at the pool.
- Children checking in will be required to give their name and birthdate.
- Misuse or abuse of the system may lead to removal from the pool and possible revocation of membership privileges.

Private Parties

- Available on a first-come, first-serve basis.
- Parties can be held at times approved by Club managers.
- No lifeguard will be provided for private parties.
- All Club rules will be in effect during private parties.

Temporary Closings

- The pool may occasionally be closed temporarily due to weather or water issues.
- No rebates or refunds will be made during temporary closings.
- The Club reserves the right to close permanently before the stated close date with reasonable efforts to reimburse prorated membership fees within 6 months.

VIOLATIONS OF CLUB RULES AND REGULATIONS

All members and guests shall abide by Club rules and regulations as promulgated by the management staff and implemented and enforced by the Club managers and employees. When conduct, as determined by a manager or an employee of the Club, is of a serious nature, the Club may choose to issue warnings as deemed appropriate. Repeated violations of Club Rules and Regulations may result in suspension from pool activities as determined appropriate by the management staff and/or revocation of membership.
